NETFISH MPEDA AP had conducted a One day Workshop on “Refinement of Marine Fisheries Management in Andhra Pradesh” at State Institute of Fisheries Technology (SIFT) Jagannaikpur, Kakinada on 20th August 2019. The programme was conducted in association with the Department of Fisheries Andhra Pradesh. The programme was aimed to bring all the major Fishery stakeholder groups, Senior State Fishery officials and Scientist from fishery research institutes to one platform to discuss on the need of amendment in the existing Andhra Pradesh Marine Fishing Regulation Act (APMFRA) which was initiated in the year of 1993 and implemented in the year of 1995.

Senior rank Officials Additional Director, Joint Director, Deputy Director, Asst Directors from Dept of AP State Fisheries, Principle Scientist from CIFT, 3 Scientists from CMFRI Visakhapatnam, Asst Director SRD, MPEDA, Bhimavaram, Chief Executive NETFISH Kochi, Presidents and Secretaries of Mechanized and Motorized fishing boat owners associations from all the major fishing harbours and fish landing centers of Visakhapatnam, Kakinada, Machilipatnam and Nizampatnam, and boat owners Vizianagaram and other districts were attended and actively participated in the workshop and spoke about the need to amend the existing APMFR Act for the purpose of sustainable fisheries. CE NETFISH had made a power point presentation of Kerala MFR Act of past and present. All the major stake holders are agreed and supported to amend the existing act in line with Kerala MFR Act, Minimum Legal Size (MLS) and to reasonable increase in boat registration, fishing license charges. All are agreed to control the size of fishing fleet and not to register the new fishing boats. The stakeholders are suggested Department of AP Fisheries to conduct regional wise harbour wise meeting along with NETFISH and consider the suggestions before finalizing the amendments of act.

During the month, NETFISH participated in the Aqua Aquaria India 2019 at Hitex Exhibition Center, Kondapur in Hyderabad. The exhibition was organized by Marine Products Export Development Authority (MPEDA), Ministry of Commerce and Industry, Government of India. The programme was conducted 3 days from 30.08.2019 to 01.09.2019. NETFISH stall was decorated with the banners of all the state activities and achievements. Dr. Joice V Thomas, CEO, NETFISH and P.Hanumantha Rao, SCO, NETFISH were attended the NETFISH stall. NETFISH kept all the leaflets, brochures, posters and videos developed by NETFISH on Fish Quality Management and Sustainable Fisheries. Shri Keshav Chandra, IAS, Joint Secretary, Ministry of commerce and Industry, Shri. Ramasakar Nayak, IAS, Commissioner of AP Fisheries, Ms. Rani Kumidini, IAS, CEO, NFDB, Shri. K S Srinivas, IAS, Chairman, MPEDA, Shri. T. Dola Sankar, IOFS, Director (Marketing) MPEDA, Shri.B.Sreekumar, Secretary, MPEDA, senior officials of MPEDA , other state fishery officials and stake holders of Fishermen cum Aqua farmers were visited the stall. As a result of NETFISH training programmes, Fishermen of Veraval Fishing harbor used their stipend money to purchase iron barrel and made it as dustbin for waste collection to keep harbor and sea clean.
